FULL TERMS & CONDITIONS

1. WHO CAN ENTER

- 1.1. This children's art competition is open to all residents of the United Kingdom aged 4 to 16 years. There are three age categories, 4-7 years, 8-11 years and 12-16 years. Entrants are asked to submit a picture of a Coronation Crown for King Charles using any medium, provided it is original artwork. All terms and conditions will be available at Customer Support Services on the 2nd floor on request or contact clc.cribbscauseway@johnlewis.co.uk for a copy to be sent by email.
- 1.2. By submitting a competition entry, you are agreeing to be bound by these terms and conditions. The instructions provided at the point of entry form part of the terms and conditions of this competition. In the event of a conflict, these terms and conditions take precedence.
- 1.3. All entries must be clearly labelled with your name, age, & contact details on the back of the artwork. We ask parents or a guardian to complete the entry form in order to obtain consent to enter and claim any prize. The Promoter may require any information that we consider reasonably necessary in order to verify your eligibility.
- 1.4. No purchase necessary. There is no charge to submit an entry.

2. DEADLINE FOR ENTRIES

- 2.1. Entries must be received by close of day **Sunday 7th May 2023 (07/05/2023)**

3. HOW TO ENTER

- 3.1. To enter, simply hand the child's artwork in person to **Customer Support** or **The Place To Eat, 2nd Floor, John Lewis & Partners, The Mall, Cribbs Causeway. BS34 5QU**
- 3.2. There is a limit of one entry per person.
- 3.3. The Promoter accepts no responsibility for entries that are lost, delayed, mislaid or damaged in transit, regardless of the cause, including, for example, as a result of any equipment failure, technical malfunction, systems, network, server, computer hardware or software failure of any kind. Proof of submitting an entry is not proof of receipt by the Promoter.
- 3.4. Any entry not in accordance with the rules or any entry containing false, incomplete or misleading information will be void and will entitle the Promoter to exclude the entry from the competition.
- 3.5. The competition is open to schools within a 30 mile radius of John Lewis & Partners, BS34 5QU. By entering this competition you are abiding by the Terms & Conditions. 4. THE PRIZE

- 4.1. There are two winners per age group, who will be notified by John Lewis & Partners, Cribbs Causeway. The first prize is a **£50 gift voucher**, with the runner-up receiving a **£25 gift voucher** in each of the age group categories, 4-7 years, 8-11 years and 12-16 years

6. WINNER NOTIFICATION

6.1 The winners will be notified by email or phone call as soon as practicable after the selection, using the contact details provided on the competition entry. The winners will be required to respond within 7 days of notification (unless otherwise stated) confirming their acceptance of the prize. In the event that a winner does not respond to communications within this period, or if any prize is declined, the Promoter reserves the right to disqualify that winner and select another winner.
